



Hilti Raffle Prize Draw - Terms and Conditions

1 General

- 1.1 This Raffle prize draw is operated by Hilti Fastening Systems Limited ("Hilti").
- 1.2 These terms and conditions govern the terms and conditions for participation in the Hilti raffle commencing on 1st April 2026 ("Raffle"). The following description and procedure outline how entrants may join the Raffle upon completing the relevant market research survey.

2 How to participate

- 2.1 In order to participate, please follow the instructions at the end of the relevant Customer Experience survey. By participating in this Customer Experience Survey you agree to Hilti using your information for the purposes of the Raffle.
- 2.2 Hilti may invite you to provide feedback in relation to a transaction including but not limited to Hilti orders and Hilti repairs. Upon completion of any such feedback submission you will automatically be entered into the applicable Monthly Draw.

3 Start and closing date

- 3.1 The Raffle will start at 00:01 on 1st April 2026. The Raffle will operate on a recurring monthly basis and will continue indefinitely unless and until Hilti suspends, amends or terminates it in accordance with these Terms and Conditions. For the purposes of these Terms, each calendar month during which the Raffle operates shall be referred to as a 'Monthly Draw'. Hilti may select one winner following the close of each Monthly Draw.
- 3.2 The closing date for each Monthly Draw will be the last day of the relevant calendar month at 11:59pm.. Entries received by Hilti after this time will be void and will not be entered into the Raffle.

4 Prize

- 4.1 The prize is one Hilti voucher ("Hilti voucher") per winner valued at €150 .
- 4.2 This voucher is only valid for the purchase of consumables including tool inserts, firestop and fire protection products, fasteners, modular support systems, façade mounting systems, and construction chemicals. Direct fastening consumables are excluded from this voucher.
- 4.3 This voucher is valid only for Hilti customers that have entered the relevant customer experience survey. This voucher is valid for one-time use only, can be redeemed online at www.Hilti.ie, and is valid for 3 months from the date of issue. Hilti is not responsible for lost, stolen, or unauthorised use of this voucher. Hilti reserves the right to withdraw this voucher or modify the terms of this Raffle at any time without notice.
- 4.4 The prize is non-transferable and does not include any additional costs and expenses. Hilti is not responsible for inaccurate prize details supplied by any third party.

5 Selection of the winner

- 5.1 The winners of the prize draw will be randomly selected from all entries correctly submitted in accordance with these terms and conditions.
- 5.2 Hilti will notify the winners by email within 14 days of the closing date of each monthly draw.
- 5.3 Hilti must either publish or make available information which indicates that a valid award took place. The winner agrees to the use of their surname and county in any publicity material, as well as their entry. The winner's surname and county will also be available 28 days after closing date by emailing the following address: ieteamcustomerservice@hilti.com. If an entrant objects to their surname, county and winning entry being published or made available, they should contact Hilti at ieteamcustomerservice@hilti.com . In all circumstances Hilti reserves the right to provide the details and winning entry to the Advertising Standards Authority on request.

6 Publicity and personal information

- 6.1 Participant's personal data will only be used as necessary and for the purpose of the Raffle (e.g., prize draw, delivery of prize). We rely on legitimate interests as our lawful basis, as this processing is necessary to operate the raffle in ways entrants would reasonably expect and with minimal privacy impact. Any further use of the entrant's personal data will only take place if it is required by applicable law or with the entrants' consent. As soon as Hilti no longer needs entrant's personal data Hilti will delete it in accordance with [Hilti's Privacy Policy](#).
- 6.2 Specifically, non-winners contact details will be deleted after the Raffle has ended and a winner has been selected within 14 days of the closing date of each monthly draw. The winner's contact details will be held for 28 days following notification to the first winner(s), after which point it will be deleted.
- 6.3 Entrant's data will only be transmitted to Hilti-internal departments that are involved in the execution of the respective processes related to the Raffle (such as, bookkeeping, accounting, marketing) and our trusted processors, as needed.

- 7.4 In the event of unforeseeable circumstances due to which the proper execution of the Raffle cannot be guaranteed (as determined solely by Hilti), Hilti reserves the right to change or terminate the Raffle or to modify these terms and conditions without notice to the entrants. This applies, without limitation, if attempted misuse or manipulation is detected.
- 7.5 Insofar as is permitted by law, Hilti, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss or damage. Your statutory rights are not affected.



7.6 If there is any reason to believe that there has been a breach of these terms and conditions, Hilti may, at its sole discretion, reserve the right to exclude entrants from participating in the Raffle.

8 Jurisdiction

The Raffle and these terms and conditions will be governed by English law and any disputes will be subject to the exclusive jurisdiction of the courts of England and Wales.
